- WATER: \$12.60 plus \$2.56 PER 1,000 GALLONS.
- SEWER: \$25.00 plus \$2.47 PER 1,000 GALLONS, BASED ON WATER USAGE.
- GARBAGE: \$20.00 FOR 1 CART A MONTH FOR ONCE A WEEK PICK- UP. AN ADDITIONAL CHARGE PER EXTRA CART.
- ANIMAL CONTROL & MOSQUITO SPRAYING: \$1.00 (.50 cents each)
- FIRE TAX: \$4.00 A MONTH

### \*\*\*COMMERCIAL\*\*\*

- WATER: \$12.60 plus \$2.33 PER 1,000 GALLONS.
- SEWER: \$25.00 plus \$2.25 PER 1,000 GALLONS, BASED ON WATER USAGE.
- GARBAGE: \$37.00 FOR 1 CART FOR ONCE A WEEK PICK-UP. AN ADDITIONAL CHARGE PER EXTRA CART.
