Donovan Weeks made a motion to approve the **July** minutes as presented. George Alexander seconded. All voted aye.

Sherri Griffin, City Clerk presented Financial Statements and Budget Review Summary. (See Attached) Tony Money made a motion to accept them as presented. Donovan Weeks seconded. All voted aye.

George Alexander made a motion to pay approved bills. Tony Money seconded. All voted aye.

Mr Garner presented Council with the new Marketing Services Agreement between the Town and Jackson County Economic Development Committee Inc. with waiver included (See Attached) Donovan Weeks made a motion to approve the agreement as presented. Tony Money seconded. All voted aye.

Sneads Carlisle Rose Garden Club requested a donation in the amount of \$500 for their District meeting. All agreed to donate to the club.

Josephine Curry, with Jackson County Senior Citizens could not attend this meeting.

Mr Garner asked for approval of bid for RFP from David Melvin Engineering for Administration and Engineering Services for Hurricane Michael. He explained this was a second time advertising and we only had one bidder both times. Tony Money made a motion to accept Melvin Engineering as the bidder pending DEO approval. Mr Garner presented Council with a Contract for our Groundwater Wells Amendment. (see attached) He stated that we needed a motion to accept the contract amendment for abandonment of wells MWI-2A and MWB-7, and develop new wells MWI-2Ar and MWB-714, in order to satisfy the agreements of the most recent wastewater facility operating permit renewal and Florida DEO Policies, at a price of \$17,355, bringing the entire project SNE21WWR to \$28,975. Donovan Weeks made a motion to approve the Groundwater Wells Amendment as presented. George Alexander seconded. All voted aye.

Mr Garner informed Council that he had set Amnesty Days for next month for September 14<sup>th</sup> - 17<sup>th</sup>.

Mr Garner reminder Council of Budget Hearing dates as September 15<sup>th</sup> and 28<sup>th</sup> at 5:01pm. He asked Council if they would like to consider moving the regular meeting to Thursday, September 15<sup>th</sup> at 5:01 as well to keep from meeting twice in once week. #### **Budget Summary**

## MARKETING SERVICES AGREEMENT BETWEEN TOWN OF SNEADS AND JACKSON COUNTY ECONOMIC DEVELOPMENT COMMITTEE, INC.

This Agreement for Marketing Services ("the Agreement") is made by and between the SNEADS, FLORIDA, (the "Town"), acting through its Town Council, and JACKSON COUNTY ECONOMIC DEVELOPMENT COMMITTEE, INC., a Florida not-for-profit corporation (the "EDC"), collectively referred to herein as "the Parties". The Parties agree as follows:

1. SCOPE OF SERVICES - The EDC shall represent the Town in specialized marketing services that help support the quality of life and economic vitality of the Sneads area. Efforts shall be concentrated on, but not limited to: to establish Sneads as an environment that is conducive to conduct business, encourage economic growth that enhances the standard of living and quality of life, and facilitates the creation of an environment that encourages the expansion of existing business and the location of new business; to bring all types of industry to Sneads.

#### 2. EDC SERVICES TO SNEADS

- A. Identify and communicate with site selectors seeking growth and investment in the Sneads area.
- B. Review, coordinate and assist new and expanding businesses on Federal, State and local business incentives available to them.
- C. Provide awareness of loan and grant programs available to the Town and to the Sneads business community and provide assistance in qualifying candidates for these grants and loans wherever possible.
- D. Coordinate job training services and programs with CareerSource Chipola and other educational partners and those businesses qualifying for training dollars.
- E. Focus on the retention and expansion of Sneads's technical workforce and business community by maintaining on on-going business contact program.
- F. Provide marketing assistance to potential domestic and foreign investors into the Sneads economy.
- G. Maintain an on-line web portal showcasing available commercial and industrial buildings and sites located within Sneads.
- H. Provide demographic and market research data to consultants, business investors, residents and government officials.
- I. Work with individual members of the Sneads Town Council and the Town Administrator to coordinate objectives.

- J. Provide periodic updates to the Town of their efforts and attend Board meetings.
- K. EDC shall comply with Florida Statute 125.045 "County Economic Development Powers" and submit an annual report to the Town detailing how Town funds were spent and detailing the results of the agencies' efforts on behalf of the Town. This report must be delivered by January 15 of each year.
- 3. **TERMS OF THE AGREEMENT** This Agreement will begin on October 1, 2022, and extend through September 30, 2023. This contract may be renewed for two (2) or more additional one-year periods on the same terms and conditions upon written agreement by both parties. This contract may be canceled by either party, in writing, without cause upon sixty (60) days written notice. Renewal of this contract shall be subject to appropriation of funds by the Town Council.
- 4. **FEES & EXPENSES** The Town will fund EDC in the amount of \$3,414.00 annually which is based on a rate of \$2.00 per resident with population determined by the Florida Office of Economic & Demographic Research Annual Estimate excluding inmate populations. If the Town is not able to pay the established amount a Hardship Waiver can be completed and turned to the Jackson EDC Executive Committee for review. This Agreement is expressly conditioned on the appropriation by the Council on an annual basis. In the event that the Council elects not to appropriate the funding for this Agreement in any fiscal year, then this Agreement shall terminate immediately upon expiration of fiscal year for which funding was appropriated.

#### 5. OTHER TERMS & CONDITIONS

It is understood that the construction, interpretation and the performance of this Agreement shall be governed by the laws of the State of Florida. It is understood that this Agreement shall constitute the entire agreement between the Town and the EDC with respect to the matters discussed herein and shall not be altered, amended, or revised except, in writing, and signed by an authorized representative of the Town and the EDC. The provisions of this contract supersede all prior oral or written agreements, communications and understandings of the Town and the EDC with respect to the subject matters contained herein.

6. **REPRESENTATIVES**: The authorized representative (bills to be mailed to this address) of the Town shall be the Town Administrator, at 2028 Third Avenue, Sneads, FL 32460. The authorized representative for the EDC shall be: Tracy Andrews, Chairman at 4318 Lafayette Street, Marianna, FL 32446. All notices required by this agreement shall be, in writing to the representative listed above with a courtesy copy to the following: Tiffany Wilson Garling, Secretary, at 4318 Lafayette Street, Marianna, FL 32446.

## WAIVER OF FUNDING CONTRIBUTION FOR COUNTY-CITY INVESTORS

#### **GENERAL**

This policy establishes parameters for waiving the funding contribution for County-City Investors as set forth in the Bylaws of the Jackson County Economic Development Committee, Inc.

#### **BACKGROUND**

County-City Investors participate in the EDC through a funding contribution based on a funding formula established by the EDC Executive Committee and approved by the City-County Investors. The contribution of the Jackson County Board of County Commissioners is determined each year during the budget cycle. The initial funding formula is \$2.00 for each resident living within a respective municipal boundary, as estimated by the U. S. Census Bureau minus any inmate population. The population source and funding formula may change from time to time as approved by the County-City Investors and the EDC Executive Committee. Any municipality within Jackson County desiring to become an EDC City Investor may do so by contributing the appropriate funding formula amount. Any municipality desiring to participate, who cannot contribute based on the funding formula, may request a waiver to be approved the EDC Executive Committee each fiscal year.

#### **PURPOSE**

The purpose of this policy is to provide an equitable means for municipalities:

- 1) To access waivers
- 2) To establish mutually beneficial partnerships between JCEDC and the municipality, and
- 3) To effectively control the manner in which the JCEDC is funded and sustained.

#### RESPONSIBILITY

Funding formula waivers are determined by the JCEDC Executive Committee.

#### **POLICY**

Waivers are for funding contributions only. Any other costs related to economic development projects are not eligible for waiver or reduction under this policy. Municipalities that demonstrate that fees will cause a financial hardship will be considered for a total fee waiver.

#### **PROCEDURES**

Requests for waiver must be made in writing by using the attached Affidavit of Financial Hardship. Affidavits should be submitted to the JCEDC Executive Director by September 1<sup>st</sup> of each fiscal year.

#### **Project Understanding**

JSA understands that Melvin Engineering is assisting the Town of Sneads to remain in compliance with their new WWTP permit. The permit is asking for the abandonment of wells MWI-2A and MWB-7. The two wells are to be replaced with new construction that is properly located for their intended purpose and have well screens that remain sufficiently below the water table for routine monitoring. Melvin Engineering has asked JSA to provide an updated cost of well construction and well abandonment (based on completed site investigations) to include permitting, PLS survey, field oversight, and well completion reporting. After well construction, the new wells are to be sampled. Those costs are provided below.

JSA will provide the labor, equipment, materials, field oversight, and permitting as necessary to accommodate the construction of Wells MWI-2AR and MWB-14 with well completion reporting to FDEP. This budget provides two (2) monitor wells constructed of 2" schd 40 PVC with threaded joints up to 55 and 65 feet below land surface with 10 feet of 0.01" slot screen. The wells will be completed above land surface with 4"x 4" locking metal stick-up protectors in 2'x 2' concrete pads. The wells will be protected with three (3) bollards, filled and grouted in place. Each well will be surveyed in place with elevations of ground surface and top of casing determined by a Professional Licensed Surveyor. The wells will be developed with a record maintained for well construction and development reports on FDEP Form 62-701.900(30).

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF SNEADS, FLORIDA, ADOPTING THE 2022-26 FIVE-YEAR CAPITAL IMPROVEMENT PROGRAM ANNUAL UPDATE; PROVIDING FOR LEGISLATIVE FINDINGS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 163.3177(3)(a), Florida Statutes, requires that local government comprehensive plans contain a capital improvements element designed to consider the need for and the location of public facilities; and

WHEREAS, Section 163.3177(3)(b), Florida Statutes, requires that local governments review the capital improvements element on an annual basis, and provides that modifications to update the five-year capital improvements schedule may be accomplished by ordinance; and

WHEREAS, "capital improvement" generally means physical assets constructed or purchased to provide, improve, or replace a public facility, typically large scale, high in cost, and may require multi-year financing; and

WHEREAS, Section 163.3177(3)(a)(4), Florida Statutes, requires that projects necessary to achieve and maintain adopted levels of service for the five-year planning period be included in the capital improvement schedule.

#### NOW, THEREFORE, BE IT RESOLVED BY THE TOWN OF SNEADS AS FOLLOWS:

- SECTION 1: The recitals set forth above are true and correct and constitute legislative findings of the Town Council.
- SECTION 2: The Capital Improvement Program Annual Update is hereby adopted as set forth in Exhibit 'A', attached hereto and incorporated herein by reference.
  - SECTION 3: The effective date of this Ordinance shall be immediately upon adoption.
- SECTION 4: This ordinance shall supersede any ordinances in conflict herewith to the extent that such conflict exists.
- SECTION 5: If any provisions or portions of this Ordinance are declared by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then all remaining provisions and portion of this ordinance shall remain in full force and effect.

#### **ORDINANCE NO. 2022-02**

AN ORDINANCE OF THE TOWN OF SNEADS, FLORIDA, AMENDING CHAPTER 4, CODE OF ORDINANCES and ORDINANCE 2015-01, TO PERMIT CONSUMPTION OF ALCOHOLIC BEVERAGES BY THE DRINK AT DULY LICENSED BUSINESSES DURING THE TIMES AND UNDER THE CONDITIONS SPECIFIED, PROVIDING AND EFECTIVE DATE

#### **ALCOHOLIC BEVERAGES**

#### **ARTICLE 1. IN GENERAL**

#### Section 1 – Definitions

"Alcoholic Beverages" means distilled spirits and all beverages containing one-half of 1 percent or more alcohol by volume.

"Wine" means all beverages made from fresh fruits, berries, or grapes, either by natural fermentation or by natural fermentation with brandy added, in the manner required by the laws and regulations of the United States, and includes all sparking wines, champagnes, combination of the aforesaid beverages, sake, vermouths, and like projects. Sugar, flavors, and may be added to wine to make it conform to the consumer's taste, except that the ultimate flavor or the color of the product may not be altered to imitate a beverage other than wine or to change the character of the wine.

"Fortified Wine" means all wines containing more than 17.259 percent of alcohol by volume.

#### **ARTICLE II. REGULATIONS**

#### Section 2 – Hours of sale of alcoholic beverages

Alcoholic beverages (which includes beer and wine) may be sold within the town limits of the Town of Sneads seven days a week (Sunday through Saturday) except between the hours of 1:00 AM and 7:00 AM.

#### Section 3 – Hours of sale and consumption of alcoholic beverages by the drink

Alcoholic beverages may be sold for consumption in a place of business, holding a license under the State Department of Business and Professional Regulation, Division of Alcoholic Beverages and Tobacco seven days a week (Sunday through Saturday) except between the hours of 1:AM and 7:00 AM.

#### Section 4.

It shall be unlawful for any person to drink any alcoholic beverage upon the Streets or in any public place, or at any place where the public is invited or may frequent during the hours

mentioned in Sec. 2 hereof during which the sale of alcoholic beverages mentioned in Sec. 1 hereof are prohibited.

#### Section 5.

It shall be unlawful for any person, firm, or in the case of a corporation, the officers, agents, and employees thereof, to sell, give, serve, or permit to be served, alcoholic beverages, to person under twenty-one (21) years of age, with the Town of Sneads, Florida.

#### Section 6.

It shall be unlawful for any person to misrepresent or misstate his or her age or the age of any other person for the purpose of inducing any licensee, his agent's, or employees, to serve, sell, give, or deliver any alcoholic beverages to any person under twenty-one (21) years of age.

#### **Section 7. Prohibition**

It shall be unlawful in the Town of Sneads, Florida, for any person, firm or corporation in an establishment licensed under the Beverage Laws of the State of Florida to sell alcoholic beverages for consumption on the premises, as authorized by F.S. 562.45(2)(b), to make, cause, or allow the making of any live or recorded, amplified or non-amplified music which is plainly audible from a distance of thirty (30) or more when measured from the exterior walls of such establishment.

#### Section 8 - Distance of licensed business from Churches and Schools

No business licensed by the Division of Alcoholic Beverages and Tobacco to sell packaged alcoholic beverages for consumption by the drink shall be allowed to conduct business in a location that is less than five-hundred (500) feet from an established church or school, which distance public thoroughfare from the main entrance of the place of business to the main entrance of the church and, in the case of a school, to the nearest point of the school grounds in use as part of the school facilities, within the town limits of the Town of Sneads.

#### Section 9 – Current distances Grandfathered in

Any business holding a license as stated above at the time of adoption of this ordinance that may be five hundred (500) feet or less from an established church or school shall be grandfathered in and all rules and regulations other than distance shall apply.

#### Section 10 – Future placement of Churches and Schools

No church or school may request placement that will infringe upon the five hundred (500) feet distance of an already established place of business licensed to sell and/or serve alcoholic beverages of any type.

MEMO TO: Council President and Councilmembers

SUBJECT: Town Manager's Report to Council – August 2022

- 1. First let me thank you for confirmation of our upcoming budget at our recent work session. It is a great feeling to know that you have a council that has confidence in you when making recommendations/suggestions to council. On behalf of all the staff, thank you again.
- 2. I am attaching a copy of the Marketing Services Agreement between the Town and Jackson County Economic Development Committee, Inc for the next year. It is the same agreement we have currently, and we will request a reduction in fees to pay zero. They are doing what they can to represent the entire county, a significant difference from years past.
- 3. We will have the second and final reading of Ordinance 2022-01 regarding Capital Improvement Plan, of which a copy is attached.
- 4. I mentioned at work session about a phone meeting with our consultant, FEMA, FDEM and others on Wednesday. We are back to square one on the replacement of lights at the sports complex. I am attaching a copy of the email, which was sent by FDEM after the phone call, along with a concise explanation from Mark Albright, our IParametrics Consultant. I recommend we proceed with the route that Mark is suggesting in hopes we can get this project, along with the rest of the work at the sports complex back on track. If we do nothing, we are faced with about \$165,000 to do all the work from the Insurance Company, which we all know is not adequate. I had Wendi Lewis, Recreation Coordinating Council President, sit in on the meeting so she would know that the Town has not been dragging its feet, but it has all been on FEMA and FDEM.
- 5. The Sneads Carlisle Rose Garden Club will be hosting the other ten (10) clubs in District No. 2 here in Sneads on Wednesday, October 12, 2022, for their Annual Fall Meeting. They have asked for a donation of \$500 from the Town to assist them with expenses for this meeting. Based on all they do for the Town and its residents; I recommend the donation be provided as requested. A copy of request is attached.
- 6. As of today, we have raised \$9650 of the \$10,000 needed for sponsorship of the boat race on August 20-21. The town will furnish porto-toilet trailer and ambulance, with these payments coming from gate money, and the rest will be revenue for the town. The gate will be handled by the Recreation Coordinating Council members, and we will give the Rec Dept a small donation from the gate receipts. Hopefully, we have a good attendance, great weather, and safe race.
- 7. Just a reminder, Council President Weeks and I will be attending FLC annual convention this week in south Florida.

- 8. I have continued to get a firm response from Mr. Whittington, owner of the property we have offered to purchase across the street from where we want to place the Public Safety Complex. The last time I talked to him, he wanted \$50,000 and I discussed the need to get an appraisal done of the property and we would be guided by the appraisal. He informed me he was going to contact an appraiser he knows to get a good estimate of what he thinks it should appraise for but have not heard from him. Town Attorney and I will continue to pursue.
- 9. We will have Ms. Josie Curry at council to discuss water assistance program through Jackson County Senior Citizens for those in need of financial assistance for payment of bills.
- 10. Again, we only got one (1) bid for the Administration and Engineering Service that was readvertised and David H. Melvin submitted it. I recommend we accept his bid and submit to State FDEM and FEMA for acceptance, as this is the second time we have advertised, and they are the only firm to submit a bid package.
- 11. Do not forget your ethics workshop on Saturday, August 27, 2022, at 8:AM CST here at Town Hall. We will not have a budget workshop on August 16<sup>th</sup> as previously scheduled.
- 12. Attached is copy of Ordinance 2022-02 for first reading regarding sale of alcoholic beverages.

13. We will have fall Amnesty Days on Wednesday thru Saturday, September 14, 15, 16 & 17<sup>th</sup>.
