RESOLUTION NO. 24-08

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SNEADS, FLORIDA; ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES FOR THE TOWN OF SNEADS FOR FISCAL YEAR 2024-2025; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Sneads of Jackson County, Florida, on September 30, 2024, adopted Fiscal Year Final Millage Rate following a public hearing as required by § 200.065, FLA. STAT. (2019); and

WHEREAS, the Town Council of the Town of Sneads of Jackson County, Florida, held a public hearing as required by § 200.065, FLA. STAT. (2019); and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Jackson County has been certified by the County Property Appraiser to the Town of Sneads as **\$47,855,286**.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF SNEADS, FLORIDA as follows:

SECTION 1. The FY 2024-2025 final operating millage rate is 4.0883 mills, which is greater than the rolled-back rate of 3.2909 mills. Percent change over rolled back rate is 24.23%.

SECTION 2. This Resolution shall become effective immediately upon its passage and adoption.



A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SNEADS, FLORIDA; ADOPTING THE FINAL BUDGET FOR FISCAL YEAR 2024-2025; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Sneads of Jackson County, Florida, held a public hearing as required by § 200.065, FLA. STAT. (2019); and

WHEREAS, the Town Council of the Town of Sneads of Jackson County, Florida, set forth the appropriations and revenue estimate for the Budget Fiscal year 2024-2025 in the amount of **\$14,176,673**;
